April 17, 2017

## **CALL TO ORDER:**

Mayor Brad Schmitt called the meeting to order Monday, April 17<sup>th</sup> at 6:00 p.m.

### **READING OF MINUTES:**

Ordinance 2017-06 was also presented to the Council for approval. It would amend Ordinance 2016-04, by replacing the purchasing agent, with the Communications Director, on the Special Events Commission.

Jim Maglis made the motion to approve Ordinance 2017-06. Sheri Greene 2<sup>nd</sup> the motion, all ayes, motion carried.

Sheri Greene made the motion to suspend the rules for a second reading. Jan Ballard 2<sup>nd</sup> the motion, all ayes, motion carried.
