# Common Council

May 1, 2017

## **CALL TO ORDER:**

Mayor Brad Schmitt called the meeting to order Monday, May 1<sup>st</sup> at 6:00 p.m.

## **ROLL CALL:**

#### **READING OF MINUTES:**

The Council discussed the issue of putting up a net in the outfield of Gil Hodges field to catch homerun balls. The Council agreed to take no further action regarding the matter.

Ordinance 2017-07 was presented to the Council for consideration. It would allow for stop signs to be placed at the intersections of Glendale & Fourth Streets and Glendale & Second Streets.

Mayor Schmitt spoke to the Council requesting them to consider adding more lighting along the trail crosswalk along Glendale Street.

Attorney Spindler presented Resolution 2017-05 which would limit cellular towers and other utility poles being placed in the City limits without City approval. This resolution would be retroactive to April 29, 2017. Greg Wright made the motion to approve Resolution 2017-05. Jim Maglis 2<sup>nd</sup> the motion, all ayes, motion carried.
